Your Rights Under the Nigerian Constitution

- Right to Remain Silent You are not obliged to answer questions without a lawyer present. (Constitution, S. 35(2))
- Right to be Informed Police must tell you the reason for your arrest immediately. (S. 35(3))
- Right to Legal Counsel You have the right to a lawyer of your choice or a free Legal Aid lawyer if you cannot afford one. (S. 36(6)(c))
- Right to Bail For most offences, bail must be considered promptly; you should not be kept beyond 48 hours without court order. (S. 35(4))
- Right to Humane Treatment No torture, inhuman, or degrading treatment is allowed. (S. 34(1))
- Right to Contact Family/Support You can insist on calling a family member or lawyer immediately.

What to Do if Arrested?

- Stay Calm Don't resist or argue aggressively.
- Ask for Identification Politely request to see the arresting officer's ID and note the name and badge number.
- State You Want a Lawyer Say clearly: "I want to speak to my lawyer before answering any questions."
- **Contact Help** Call a trusted person and give them details of your location, arresting officers, and station name.
- Do Not Sign any statement or confession without your lawyer's advice.
- Document Everything If safe, note dates, times, and names; if you're released, write down events while fresh.

Document everything.

Keep records of names, places, times, and any evidence. Inform friends or family of your location and the organizations you've contacted.

Seek advice from NGOs or clinic support.

Even without direct phone lines, organizations like CLO, CRP, LEDAP, Access to Justice, and university clinics can assist—especially if referred through other agencies.

Bail Basics

- Bail is free for most minor offences police cannot demand money for granting bail. (Police Act 2020, S. 64)
- Bail conditions should be reasonable; sureties must be clearly informed of their obligations.
- ☐ If bail is refused at a police station, you can apply to a magistrate court.
- □ Always collect and keep a copy of your bail bond form.

Quick Tips

Save emergency numbers in your phone under "Lawyer – Emergency" and "Rights Helpline".

Share your live location with a trusted contact if being taken away.

Keep copies of important IDs and phone numbers with a trusted person.

Legal Aid Council	Free legal representation to eligible indigent detainees; must be offered at arrest.
National Human Rights Commission (NHRC)	Investigates rights violations, visits detention centers, offers redress/remedies.
Public Complaints Commission (PCC)	Ombudsman handling administrative misconduct by public/private entities.
Civil Liberties Org (CLO), CRP, LEDAP	NGOs offering legal aid, advocacy, and rights defense.
Hope Behind Bars Africa	Support and legal aid for pre-trial detainees; focuses on indigent justice access.
Access to Justice	Promotes fair legal access and system integrity, especially for marginalized groups.
Citizens' Gavel (via Podus app)	Tech-enabled access to pro-bono lawyers and justice support.
University Law Clinics	Free legal services and rehabilitation assistance via law students.
Police CRU / Commissioner of Police	Channels to formally report police abuses and unlawful arrests.
Civil Liberties Organization (CLO), Constitutional Rights Project (CRP), LEDAP, Access to Justice	These offer legal aid and advocacy but may require outreach via their websites or local offices. Nigeria - Action4JusticeWikipedia
University Law Clinics	Often accessible through nearby law schools—they may be contacted via the institutions' websites or student affairs offices.
